CERTIFICATE OF CONFORMITY

Amazon Cloud Web Services (AWS)

Within the powers granted to the National Security Authority by article 4 (2)(f) of the Decree-Law no. 3/2012, of 16th January, republished by the Decree-Law no. 136/2017, of 7th November, and altered by the Decree-Law no. 139-A/2023, of 29 December, I hereby certify that the Amazon's Infrastructure-as-a-Service (IaaS), Services, aka AWS, complies with the Portuguese security requirements defined for Cloud services that process classified information up to the NATIONAL RESTRICTED level.

This certification is valid for services hosted in the European Union, as long as they are enabled with multifactor authentication through the AWS Identity and Access Management service for all accounts. A Direct Connect connection must be used to access resources available within Virtual Private Clouds (VPCs) protected on the network through Network Firewall, Web Application Firewall (WAF) and AWS Shield with protection for the distribution of services or content through Elastic Load Balancing (ELB), Cloudfront (CDN service) and DNS Route 53.

The configuration of any environment must be done through AWS Config or Systems Manager and take advantage of EC2 services for creating compute nodes, as well as Elastic Block Store (EBS), Elastic File System (EFS), FSx for Windows File Server, Relational Database Service (RDS), S3 and S3 Glacier for storing information, as well as monitoring and logging through Cloudwatch and Cloudtrail.

The management of certificates, keys and cryptographic secrets for encrypting stored and transited data must take advantage of its own vault with a maximum term of one year, using private channels.

This certification is valid until the 19th of July 2024.
